## MINISTER'S FOREWORD

History shapes the choices we make – we have the agency to remain trapped by its legacy or to break with it. Transformation and broad-based empowerment are part of a strategy to break with the past by building an inclusive economy that draws on the talents of the widest range of South Africans and provides opportunities for all citizens to have better lives.

At its heart, the strategy seeks to combine the need for historical redress with the imperative of growth and job creation through opening up the economy to black professionals and entrepreneurs and to build the capital base owned by black industrialists, workers and communities.

This book sets out the details and stories of a number of black-owned businesses in many parts of the economy.

These snapshots represent industrialists who have partnered with government and utilised the support programmes available to start, maintain or expand their businesses. They have drawn on funding through loans, equity or grants available to firms in the economy, or benefitted from measures promoted through competition regulatory agencies, or took part in programmes facilitated in partnerships with the private sector via sector masterplans.

Taken as a whole, many firms have prospered, employing large numbers of workers, exporting products across the world and adding to the country's GDP.

This points to the dynamic relationship between industrialisation and transformation. The industrialisation agenda seeks to support the emergence of dynamic firms in the South African economy through efforts in partnership with the private sector. To provide the scale required for competitive manufacturing, public policies support a twin approach: one element focusses on growth opportunities in the domestic market (through localisation, beneficiation, promoting the green economy and fostering higher levels of investment) and the second element is directed at building a wider export market (particularly in the rest of Africa, through the AfCFTA).

While public policy is directed at expanding the size of markets for SA-made goods, it is also vital to promote supply-side reforms at economy, sector and firm level to build industrial competitiveness and support job-creation.

Transformation policies – to promote economic inclusion – have three broad focus areas:

- First, strengthening inclusivity through broadening ownership and more inclusive corporate governance models. These include promoting a greater spread of ownership in the economy (including for black industrialists, women and youth) and supporting worker share ownership.
- Second, addressing structural challenges to growth through active competition policies, particularly where concentration levels in the market limit new entrants and small and medium businesses. Structural transformation includes measures to support SMMEs,
- Third, promoting spatial transformation, enabling more balanced growth between rural and urban areas and between provinces. Spatial transformation includes measures to promote equitable spatial development through district-level spatial industrial initiatives (including SEZs) and supporting the growth of the township and rural economy.

While the policy framework on broad-based black economic empowerment has evolved, its strategic intent has been guided by the Broad-Based Black Economic Empowerment Act of 2003. The legislation aims to ensure that black people, women, workers, youth, people living with disabilities and people living in rural areas are empowered, through a series of integrated socio-economic measures.

These measures include skills development, preferential procurement, investment in black-owned and managed firms, and increasing the number of black people who manage, own and control enterprises and productive assets in the economy.

Such measures have been deployed in the context of an economy with a high degree of market concentration which in many cases limit the opportunities for new entrants or small and medium sized firms.

The Competition Commission recently published the results of a study of 178 economic sub-sectors that quantified current high levels of concentration. The study found that of the 144 sub-sectors of the economy with sufficient data, about 70% were found to be highly concentrated, 21% were moderately concentrated and less than 10% had unconcentrated markets. It found that

- such levels have persisted with already highly concentrated sectors experiencing increasing concentration in a number of cases;
- merger activity in government-licensed industries has consolidated ownership;
- the number of SMMEs is growing but they have a low share of value-add and face high exit rates; and
- there is a far higher degree of inequality in the distribution of firm income than household income.

And what it shows is that a small number of firms dominate key sectors. In particular, the agricultural value-chain stands out as having large declines in participation at the farm level with growing concentration for inputs and processing. The Study also reflects on the international experience on economic concentration: the challenge of economic concentration is not limited to SA but its impact is particularly severe in SA.

The findings of the Report is not an argument against large companies, because SA needs large local firms that can be our champions in global markets, and provide us with the economies of scale and base for technological innovation to drive our growth and development. It points however to how the structure of concentrated markets can act to keep small and medium players (which include many black industrialists) out of markets, with impacts on inequality, a narrow base of entrepreneurship and weak economic performance. South Africa pays a heavy price when the base of the economy rests on a narrow demographic.

A number of public policy measures seek to address and reverse these constraints. The more successful measures are creating new and dynamic enterprises in a number of critical value-chains across all nine provinces, crowding in additional investment from the private sector as well as creating and saving a considerable number of jobs.

Funding for Black Industrialists, provided by **the dtic** and its entities, is creating platforms for a new entrepreneurial and innovative industrial class that can boost industrialisation and fully harness the resources of our country. A significant number of black industrialists who have started production have increased their output since the start of their participation in the programme.

Our efforts have also focused on ensuring workers have ownership in the firms they work in. These cover hundreds of thousands of workers currently. Some firms have now agreed to the inclusion of worker representatives on company boards. This lays the basis for a potential shift in plant-level industrial relations, from high levels of adversarialism, to a greater level of cooperation to expand output, creating an inclusive South African corporate model.

Recent examples include employee-ownership schemes at multinational corporations operating in South Africa, such as Pepsico and Coca-Cola. Recently, Imperial Logistics' local operations ensured that their nearly 13 000 workers have access to an ownership stake in the firm they work for. We also see similar community schemes in the renewable energy sector. These are examples of what companies can do, and we look forward to others following their lead, as we drive an enhanced model of broad-based transformation, through worker and community empowerment.

The Competition Act has been particularly important in promoting measures for greater economic inclusion – ranging from enhancing broad-based empowerment in the shareholding of firms, to establishing supplier development funds that promote a transformed supply-chain.

The regulatory frameworks set out in the B-BBEE Act is sufficiently flexible to accommodate a number of different approaches to transformation. Multi-national corporations who are not able to introduce local equity arrangements can use the Equity Equivalent Investment Programme to support local entrepreneurs.

Masterplans at industry level have transformation measures in these 'sector social pacts'. In the automotive industry, some R6.4 billion has been committed by automotive manufacturers towards the creation of an Automotive Industry Transformation Fund, which is providing funding and market access opportunities for black component manufacturers and firms in the automotive value-chain. In the agricultural sector, R1 billion has been committed to improve opportunities for black sugar farmers, while in the poultry sector, the industry has committed R1.7 billion to expand opportunities for black farmers. Each of these commitments complements the funding which government has provided through **the dtic** and its entities.

The country's industrialisation efforts around strategic localisation have boosted domestic supply-capacity in a growing number of areas, with black South Africans participating in these economic opportunities. This effort has been bolstered by the social compact with organised business and labour to work together to improve local capacity to replace up to 20% of the country's non-oil import bill.

While there are clearly opportunities in the domestic market, South African firms can benefit from exports. The development of an African Continental Free Trade Area (AfCFTA) will expand opportunities for South African firms in key product and service markets across the continent, including creating access to what is and will be a significant consumer market for black industrialists. This project is a big part of our growth story and presents a significant opportunity for the diversification of our economy and that of our continental partners, and for thorough-going and inclusive structural transformation of the economy.

Other features of our approach to empowerment include spatial initiatives such as special economic zones and other measures that provide access to physical infrastructure, and actions to promote township and village-based micro-enterprises. Through each of these efforts, we are opening up and changing our market structure, paving the way for new entrepreneurs and industrialists, while also shifting industrial production to the rural areas in order to bridge the urban-rural gap in value-added production.

There have been many lessons learnt over the years, which we will use to make the funding and other packages of support offered by government more targeted and efficient.

I would like to thank the staff of **the dtic**, and its entities the IDC and the NEF for their work in implementing black industrialist support over the last five years, and challenge them to improve the access and efficacy of this funding in the years to come.

# INTRODUCTION

The Department of Trade, Industry and Competition (**the dtic**) and its agencies, the Industrial Development Corporation (IDC) and the National Empowerment Fund (NEF), have a mandate to support economic growth, job creation and transformation. The department uses industrial development, trade policies and competitiveness measures to broaden empowerment and economic inclusion.

This report addresses one aspect of **the dtic's** broad transformation mandate, focusing mainly on the department's support to black industrialists. In addition, the NEF showcases some of its funding activities, including projects such as property ventures. Detailed information on the impact and beneficiaries of wider empowerment initiatives and programmes is still being collated – this report focuses on current activities in support of black industrialists. Future reports will include additional information on broader empowerment initiatives and impact analysis.

## Empowerment policies for transformation

Empowerment has evolved into a policy with multiple objectives within an overarching policy framework. Empowerment aims to:

- Redress and deal with the historical exclusion of black people from the mainstream economy and the legacy of economic exclusion of black people;
- Lay the foundation for deeper growth through greater economic inclusion that widens the talent pool of enterprises drawn from black South Africans, including women and young people; and
- Address the huge inequalities of South African society, a challenge that is unique to the country.

Over the years, the focus of empowerment has evolved, from individual share ownership, which typically comprises a non-controlling share of an existing business and which advances capital accumulation among black South Africans, to

- Broad-based empowerment made up of communities, consortia of women or youth, and collective investment and empowerment vehicles funding key social programmes such as community bursary schemes;
- Black industrialists who have a controlling stake in a company and who are often involved in its executive management; and
- Expansion to ownership by employees and developing an inclusive South African corporate model, shifting from an adversarial approach on the shop floor to a more cooperative, mutually beneficial model of industrial relations.

## Challenges

While objectives of empowerment remain a constitutional imperative, challenges remain in giving effect to policies:

- Fronting practices continue in which companies misrepresent the position of true shareholders and beneficiaries by falsifying black South Africans as owners; and
- In some cases, black-owned firms have lent and continue to lend their names to tender documents while the work is done by other companies.

**the dtic** and its agencies have strengthened its regulations and tightened controls, making fronting a criminal offence. The following are among the measures introduced by the IDC to check ownership claims to curb fronting:

- A due-diligence process that includes interviews with the client (entrepreneurs and project promoters).
- Due diligence consists of an assessment of the client's management team, a legal review, compliance checks and a review of shareholders' personal balance sheets.
- Zero tolerance towards fronting and investigation of transactions by teams that are sufficiently informed and educated about fronting practices.
- The teams, through due diligence, ensure that transactions do not involve fronting and, where required, provide evidence to the credit approval committee; and
- A hotline to report fraud, including fronting.

## Observations

This report does not cover equity promotion comprehensively, but focuses on a sample of firms and entrepreneurs that have partnered with **the dtic** and its agencies on its programmes that support black industrialists and black entrepreneurs. This is not a comprehensive list of public policy measures supporting shareholding expansion. It does not include:

- Firms and industrialists empowered through the Equity Equivalent Investment Programme, through which multinational corporations support local entrepreneurs;
- Empowerment commitments obtained as part of masterplans in sugar (R1 billion), poultry, clothing and autos (R6 billion);
- Spatial initiatives such as special economic zones and industrial parks that provide access to physical infrastructure, and measures to promote township and micro-enterprises;
- Competition market access measures that create new commercial opportunities;
- IDC's support of black shareholders for minority equity arrangements; and
- B-BBEE codes and sector charters involving thousands of other transactions promoting black shareholding or industrialist initiatives.

Research will be undertaken to provide information across additional platforms to provide a comprehensive picture of the extent of support and its impact on growth and job creation.

## Beyond shareholding

Empowerment policies are not confined to shareholding and ownership. Other key elements include the promotion of local procurement, entry of black South Africans, young people and women into management, skills development for blue-collar workers and bursaries for young persons.



## Focus on industrial expansion:

Early Black Economic Empowerment focused primarily on enabling black South Africans to obtain a non-controlling stake or equity in existing enterprises. In 2015, Cabinet approved the Black Industrialists Policy, which seeks to increase participation of black South Africans in ownership and control of productive enterprises in key sectors and value-chains of the economy. **the dtic** has advanced the objectives of the Black Industrialists Policy through grant funding to applicants who want a foothold in key, productive sectors of the economy. The IDC and NEF provide funding to eligible black entrepreneurs, including those who would have had difficulty obtaining funding from commercial banks. It is important to note that the Black Industrialists Policy has not replaced existing policies, but complements them.

## DREAMLAND PIGGERY




Dreamland Piggery was founded by Anna Phosa in 2004 with just 4 pigs. Ms Phosa has grown the business to a 300 sowcrate piggery and abattoir where 100 pigs are slaughtered daily. Dreamland also produces its own maize on 140 hectares of dry and irrigated land to produce pig feed.

The piggery currently employs 40 permanent people and sells pork to various markets including Pick'n Pay, Massmart and Spar.

## MAJESTY OIL MILLS (PTY) LTD






The plant has been commissioned and is producing 800 tons of soya seeds a day, which is contributing to reduced quantities of imported soya bean oil cake and soya bean oil. An investment in the hot dehulling plant enabled the project to increase crush volume, which has decreased the production cost. Energy saving measures instituted have improved energy use and lowered energy costs. All procurement is done locally and that the company exported goods with an approximate value of R100 million to Zimbabwe in the current financial year.

Funding was received for machinery & equipment and for buildings owned by the company. Enabled the expansion of an existing facility, which employs 322 people and manufactures soya and sunflower products such as cooking oil and soya de-oiled cake for the animal feed industry.

## MANELI PET FOOD (PTY) LTD






Nhlanhla Dlamini established Maneli Pets in 2016, they supply novel protein to the export market. Ingredients (e.g. ostrich, venison, chicken lamb and pork) are sourced from across SA and from the rest of Africa.

In February 2022, the company reported producing between 120 000 and 240 000 units per month and exporting two to four containers per month to the UK, USA, Germany, Netherlands Belgium, Italy, UAE, Singapore, Hong Kong, Macau and South Korea. The exports bring in an estimated R1 to R2 million per month.

In South Africa, Maneli's products are also sold to various retailers including Woolworths. The company invested in solar panels to conserve energy.

## NKOMAZI COTTON DEVELOPMENT PROJECT






The project is in partnership with 1 190 black individual members from 21 primary cooperatives on 11 000ha (63% of the farmers are women). On completion, the project will create 42 permanent jobs at the gin, with an additional 40 to 100 seasonal jobs and 200 jobs during construction. Upstream, the Lebombo Cooperative will be able to sustain a further 16 500 permanent jobs at full productivity.

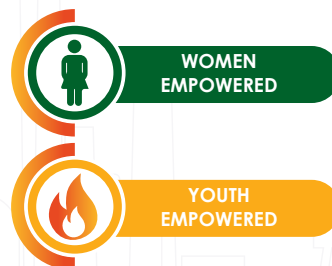

## BARAMAKAMA POULTRY (PTY) LTD

Baramakama Poultry in Molete City, North West, was started by Solly and Ofentse Moloko in 2017. This community-driven poultry has changed opened with one chicken house, now has housing of 10 200 layers, all capitalised by themselves.






A gap analysis showed that Baramakama needed to move into the formal market and they used **the dtic** incentive to build a pack house with the latest grading machine which can grade and pack 45 000 eggs per hour. The state-of-the-art grading machine is important as it assists in the FSA accreditation required to supply the formal retail market. Baramakama Poultry houses has increased their capacity to 276 000 layers. They now supply commercial stores and suppliers.

Baramakama Poultry also has a green plan based on their Environmental Impact Assessment (EIA) which includes: packaging waste is recycled as part of its EIA requirements. Future plans are for pack-houses to be off-grid and the 30 cubes of manure produced per day are given to local farmers in the surrounding areas, which in future will be used for a biogas plant which will also produce organic manure. This will create further employment.

The incentive created 48 additional jobs across divisions. In the pack-house, there are 30 permanent staff and 12 temporary staff members for weekends: 33 are women, three employees are above the age of 35 years and all are Black and come from the local community, which is a rural village. 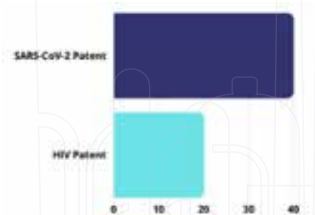


Figure 1: Patent progress on cell-based therapies for viral infections SARS-CoV-2 and HIV
